Rules and Regulations

- 1. Exhibitors are required to man booths at all times.**
- 2. Exhibitors must comply with all state and county, ordinances, regulations and statues as it pertain to the building industry and to this show.**
- 3. Any company promoting installation of products must send in copy of license to Maui Contractors Association office and post contractors license in booth at all times.**
- 4. Covering the top of any booth is prohibited.**
- 5. Outside tables, chairs, and electrical equipment are prohibited; rentals available through Jackie, which will require an onsite cash payment.**
- 6. Booth displays must be completed during assigned setup hours or deposit will be forfeited.**
- 7. Booth displays are to be removed during the assigned hours or deposit will be forfeited. (Fire Marshall Rule: All fines associated with citations by the Fire Marshall will be the responsibility of the participant).**
- 8. Exhibitors are responsible for any damage to the facility made by their display.**
- 9. Exhibitor parking will be designated prior to Expo. Our office will let you know of parking arrangements and parking passes will be mailed out.**
- 10. Vehicles not permitted in show area.**
- 11. No food or beverages are permitted in gym.**
- 11. 24 hour security will be provided during the show.**
- 12. Maui Contractors Association prohibits the sharing of any booth with another person, company or organization.**
- 13. All exhibitors must provide a certificate of insurance and list Maui Contractors Association as additional insured's on the exhibitor's general liability insurance policy prior to event. Listing should be: Maui Contractors Association 319 Ano Street, Kahului, HI 96732.**
